

# Governments are Corporations

## PERSONS, ENTITIES, CORPES, DEAD

### Information Sheet

#### The Clearfield Doctrine

Clearfield Trust Co. v. United States, 318 U.S. 363-371. states:

Governments descend to the level of mere private corporation, and take on the characteristics of a mere private citizen where private corporate commercial paper [ Federal Reserve Notes] and securities [checks etc] is concerned. For purposes of suit, such corporations and individuals are regarded as entities entirely separate from government.

Bank of United States v. Planter's Bank, 9 Wheaton (22 U.S.) 904, 6 L. Ed. 24; U.S. v. Burr, 309 U.S. 242; In re King - Porter Co., CA 5th, 1971, 446 F.2d 722,732. And: See also 22 U.S.C.A. 286(e), the real party in interest is not the de jure "United States of America" or "State", but "TheBank" and "The Fund." (22 U.S.C.A. 286, et seq., C.R.S. 11-60-103).

Corporation Government acts and statutes are only enforceable upon a PERSON. A Live Life Claimant is not a PERSON.

#### Example of a corporation committing fraud

The corporation registered and known as HER MAJESTY QUEEN IN RIGHT OF NEW ZEALAND is listed as a "CORPORATION". It is not a living queen, it is a corporation. It cannot swear an oath, it cannot breath. A corpse cannot own land or earth or air or soil or water. This corporation creates land titles 'a piece of paper construct' to the air above the earth for tenants only, not land owners. Its an illusion, the great deception. A corporation only has jurisdiction on the seas. Only a living man has jurisdiction on the earth.

Governments lose their immunity and descend to level of private corporations when involved in commercial activity enforcing negotiable instruments, as in fines, penalties, assessments, bails, taxes, the remedy lies in the hand of the state and its municipalities seeking remedy.

Rio Grande v. Darke, 167 P. 241. And:

#### Governments are corporations.

Penhallow v. Doane, 3Dallas 55. And:

Private corporations and their officers are not immune from civil damages."The principles of estoppel apply against the state as well as individuals.

(Cal. v. Sims, 32 C3d 468).

It is well settled that an officer must be either elected, appointed or commissioned. Employees cannot be made officers "by virtue of their employment." Even if they could, I.C. 59-703 (9) states, "Public office" means any position in which the normal and usual duties are conducted on behalf of a governmental entity."

**Government:** All governments are corporations which provide services. The Corporation is a legal fiction and requires another legal fiction with which to transact. "Inasmuch as every government is an artificial person, an abstraction, and a creature of the mind only, a government can interface only with other artificial persons. The imaginary, having neither actuality nor substance, is foreclosed from creating and attaining parity with the tangible. The legal manifestation of this is that no government, as well as any government law, agency, aspect, court, etc. can concern itself with anything other than corporate, artificial persons and the contracts between them." (PENHALLOW v. DOANE'S ADMINISTRATORS). Since the government is a creation of the people, it cannot possibly have jurisdiction over its creators, unless by consent. Statute enacted by government legislation requires consent from each man and woman in order to be valid. All governments and corporations, including all of their agents, are bound by the Crimes Act 1961.

**Person** - God's Law: God is no respecter of PERSON s (KJV Acts 10:34).

**Person** - Man's Law: PERSON is a dead entity; a corporation; a legal entity; a thing; an artificial construct; an actor in a play; an actors mask; a persona; an artificial person and a corporate entity.

**Person** - Blacks Law Dictionary (9th Ed.) "Artificial PERSON s" - An entity, such as a corporation, created by law and given certain legal rights and duties of a human being; a being, real or imaginary, who for the purpose of legal reasoning is treated more or less as a human being. Also termed fictitious person; juristic person; juridical person; legal person; moral person. Cf. LEGAL ENTITY

**Person** - Goods and Services Tax Act 1985 registered PERSON as a trading name.

**Person** - Births, Deaths, Marriages, and Relationships Registration Act 1995 child includes a still-born child; still-born child means a dead foetus; birth certificate means a document issued by, and signed or sealed by or stamped with the seal of, a Registrar; and containing registered birth information;— and, in relation to any PERSON, means a birth certificate containing registered birth information relating to the person's birth. MEANS DEAD. Registrar issuing it shall cause it to bear the expression "still-born" or, as the case requires, "deceased".

**Person** - Legal owner of a Land Title.
